OVERVIEW OF 2016 (insert 3-4 paragraphs reflecting highlights for the year)

• One of the key accomplishments in 2016 was the organization of a Hands Across Borders international workshop in Glacier National Park, USA (13-18 September 2016). This was a cooperative effort of several organizations, namely US National Park Service, Parks Canada, University of Montana, IUCN WCPA – Transboundary Conservation Specialist Group (TBC SG), International Peace Parks Expeditions (IPPE), Glacier National Park Conservancy, and Waterton-Glacier International Peace Park Assembly. A week-long event included a three-day capacity building workshop for about 50 transboundary conservation practitioners, field trips in Waterton-Glacier International Peace Park, and the 84th Waterton-Glacier International Peace Park Assembly. It was organized on the 100th anniversary of the US National Park Service and welcome speeches were provided (via short videos) by the Canadian Prime Minister, US Secretary of the Interior, Canadian Minister of Environment, and US Senator.
TBC SG members of the Leadership team (Matthew McKinney, Michael Schoon, Maja Vasilijević,

Todd Walters and Kevan Zunckel) all worked on particular aspects of the workshop. The curriculum, including presentations, was developed by Michael, Kevan and Maja. Todd was in charge of communication with the participants who provided profiles of their transboundary initiatives, and Matthew led general organization of the event.

The workshop built on the IUCN WCPA's Best Practice Protected Area Guidelines *Transboundary Conservation: a systematic and integrated approach* (2015), which were widely promoted. Fifteen members of the TBC SG (including seven Executive Committee Members) attended the workshop. Due to a large number of TBC SG members attending the meeting, we managed to organize a members meeting.

Apart from the workshop, the TCB SG was presented at a sister-event, the Waterton-Glacier International Peace Park Assembly organized by Rotary International.

We managed to present the Diagnostic Tool for Transboundary Conservation Planners and generate considerable interest for it. The tool might be tested on Grenada, in Waterton-Glacier in relation to cooperation with the Blackfeet Nation, and US-Mexico Border (Big Bend NP). It is planned to try to organize similar workshops at the regional level as the participants found the workshop to be very valuable for their work.

- Maja Vasilijević attended a TransParcNet meeting organized by EUROPARC Federation and held in Bad Schandau, 7-10 June 2016. The host was Saxon-Bohemian Switzerland National Park Region. The meeting is a regular yearly gathering of transboundary practitioners and this year's event explored best practices and challenges in visitor management in European transboundary conservation areas. Maja presented the TBC SG and its activities, including the best Practice Guidelines on transboundary conservation.
- At IUCN World Conservation Congress, Hawaii, USA, 1-10 September 2016, a major achievement
 was the adoption of the IUCN WCPA Best Practice Guidelines No. 23 Transboundary
 Conservation: a systematic and integrated approach, through adoption of a WCC Resolution
 'Transboundary cooperation and protected areas' (WCC-2016-Res-035-EN)
- From May to August 2016 Kevan Zunckel was contracted, together with fellow SG member

Dominique Verdugo, to work with key stakeholders from the conservation sectors in Djibouti and Ethiopia, to compile a Joint Management Plan (JMP) for the proposed Lower Awash – Lake Abbe Transboundary Conservation Landscape. The Diagnostic Tool for Transboundary Conservation Planners was used primarily to test the feasibility of the initiative, but also served well to help the stakeholders to systematically interrogate the natural, social and economic aspects of the initiative and the target area. This helped to generate a shared understanding of all these aspects and facilitated the process of developing a shared vision and joint management objectives as the framework for the JMP.

The IUCN WCPA initiative "PANORAMA: Solutions for a Healthy Planet" hosted a webinar entitled "Transboundary Protected Area Solutions" on 7 December 2016 and a number of SG members were involved in assisting with the development of the webinar (Kevan Zunckel and Maja Vasilijević), presenting case studies (Brady Mattsson together with Andrej Arih -"Promoting transboundary co-existence of large carnivores"; and Marina Djernaes on behalf of Gidon Bromberg - "Good Water Neighbors: Rehabilitating the Jordan River through transboundary cooperation), and providing an introduction to the SG and some closing comments (Charles Besançon).

PROGRESS AGAINST GOALS (Comment on progress on goals set for 2016. Add more lines if needed)

Goal 1: Support the development and dissemination of transboundary conservation knowledge products

Progress is satisfactory as we promoted the Best Practice Guidelines No. 23 at all attended events and we also co-organized an international workshop Hands Across Borders for which training modules on three topics (co-management, governance and financing) were developed.

Goal 2: Continue strengthening the information flow on transboundary conservation through the **Global Transboundary Conservation Network**

Regular communication via transboundary e-listserv and regular updating of TBC SG managed website www.tbpa.net was done throughout the year.

Goal 3: Promote and strengthen good transboundary conservation governance

Transboundary conservation governance principles were promoted during the Hands Across Borders workshop and participants' capacity in transboundary governance was strengthened.

Goal 4: Support research on the importance of TBCAs in the face of climate change

ORGANIZATION (Comment on implementation of changes to region/theme structure)

The Executive Committee consists of 15 members. Kevan Zunckel became Co-Chair of the SG in February 2016, and his position of Regional Coordinator for South and East Africa was replaced by Piet Theron. Tanya Rosen left the Executive Committee as Vice Chair (no replacement foreseen). Saleh Dadjouy and German Andrade also left the Executive Committee due to other obligations. After the selection process, two new members joined the Executive Committee; Gidon Bromberg as Regional Coordinator for West Asia and North Africa, and Patrick Lynch as Regional Coordinator for South America. Charles Besançon joined the SG as a Senior Advisor in July 2016.

MEMBERSHIP (Comment on recruitment of members in regions and themes, gender and youth)

- TBC SG currently has 276 members from all WCPA regions.
- In terms of gender, 68% are male and 32% female.
- The highest number of members come from Europe and North America.

- Discussions with BfN about cooperation and BfN's support to organization of a workshop on the island of Vilm. BfN approved funding for two workshops on Vilm, in 2017 and 2018. One will focus on the review of the Diagnostic Tool for Transboundary Conservation Planners (developed by TBC SG in 2012).
- Rahimatsah Amat held preliminary discussion with Scott Perkin, Head of Natural Resources Group, IUCN Asia Regional Office in Bangkok on the prospect of TBC SG getting involved with Asia Protected Areas Partnership (APAP). One of the core objectives of APAP is to promote transboundary cooperation. Potential of organizing a training event for APAP members on transboundary protected areas.
